Annually, TVLL forms All Star teams to represent the league in the district, state, regional and World Series tournaments. Selection to a TVLL 2024 All Star team is an honor that entails certain responsibilities, obligations, and expectations for players and their families for as long as the tournament team is active in the 2024 Little League Tournament play. Selection to said teams is a privilege and not a right. Further, by submitting this form I/we understand, the All Star team is **not** an **"equal playing time"** event.

By submitting this Letter of Intent, I/we clearly understand and agree to the following:

- 1. The above named player is eligible for selection to an All Star team according to the criteria set forth by Little League International.
- 2. The above named player is available to <u>fully</u> participate on an All Star team, if selected, by attending scheduled practices and games for as long as the team remains active in sanctioned Little League tournament play at the district, state, regional or World Series level.
- 3. A selected player that is judged by their tournament team manager to be excessively absent from practices or games or to be unfit due to misconduct or inappropriate behavior on or off the field may be removed from the team at the manager's discretion.
- 4. Additional costs related to travel expenses may be incurred. Fundraising may be done as needed to help offset a portion (but not all) of the cost to the league and families. Each player is expected to participate in fundraising activities.
- 5. It is important that players and families understand the time commitments associated with All-Stars and can commit to participating in practices, games and team activities. While we understand many families make travel arrangements long before the summer months, we ask that each family and player take the time to consider whether or not they can commit their time to the TVLL All-Star team practices and games in advance.

Social Media Policy:

As a representative of TVLL, both players and parents are expected to conduct themselves in a professional manner at all times. By submitting this Letter of Intent, you agree that you will not make disparaging remarks regarding the league, its representatives, officials, volunteers, coaches or players at any time, whether in person or on any form of social media. Doing so will result in the immediate removal of the player from the All-Star team.
